Will of John Fox (d. 1739).

In the name of God, Amen the Twenty Eight day of May in the year of our Lord 1739 I John Fox of Skale in Roborondale in the parish of Melling and County of Lancastre. husbandman, being weak in bodie but of perfect mind & memory Thanks be given to Almighty God for the same & calling to mind the mortality of my bodie, & knowing that it is appointed for all men once to die, do make & ordain this my Last Will & Testament: That is to say, principally and first of all I recommend my soul unto the hands of God that gave it; and for my bodie I recommend it to the Earth, to be buried in a Christian like & decent manner, at the direction of my Executor hereinafter named and as touching such worldly Estate, wherewith it hath pleased God to bless me with in this life, I give and devise & dispose of the same in the following manner.

First of all I give to Ann Fox my wife the sume of Tenn Shillings of good and lawfull money of great Brittain to be paid by my said Executor hereafter named out of my personal Estate, together with her widows right out of my Estate.

Secondly I give to my well beloved son Gilbert Fox all my land messuages and tenements & singular my goods & chattels and all my personal Estate whatsoever by him freely to be possessed and enjoyed he paying the Legacies hereafter mentioned That is to say,

Thirdly I give to Ellin Skerrow the wife of Thomas Skerrow my eldest daughter the sume of Two Shillings & sixpence.

Fourthly I give to Mary Howson the wife of James Howson my second daughter the sume of Two shillings & sixpence.

Fifthly I give to Agnes Darran the wife of Edmond Darran my daughter Two Shillings and sixpence.

Sixtly I give to Joan Fox my Daughter the sume of Two Shillings and sixpence.

And lastly I make & ordain my aforesaid son Gilbert Fox whole Executor of this my Will & Testament ratifying and confirming this and no other to be my last Will & Testament In witness whereof I have hereunto set my hand and seal, the day & year above written.
